

Wholesale Terms

WHOLESALE REQUIREMENTS

Participating businesses must have a brick-and-mortar shop located in Nova Scotia. Sow Local Seeds reserves the right to refuse entry of a business into the program. Location of the store, the customer base, the proximity to another store with a Sow Local Seeds rack and payment are considered among other eligibility factors.

Minimum season-opener order of 120 packets. Minimum reorder is 20 packets (in multiples of 5 or 10 per variety).

By participating in the wholesale program, you agree to the General Terms and Conditions and the Sow Local Seeds Privacy and Security Policy.

PAYMENT TERMS

All orders must be placed and pre-paid online at www.sowlocalseeds.ca. We reserve the right to change prices, quantities, and terms without notice. We reserve the right to hold orders if a payment is overdue. Order confirmations are emailed once secure checkout is completed. E transfers are to be sent to erika@sowlocalseeds.ca

SHIPPING AND HANDLING

We ship via Canada Post. Initial seed rack orders ship for free or are delivered in person by Sow Local Seeds. A reorder minimum of 20 packets (multiples of 5 or 10 per variety) qualifies for free shipping. Special orders may incur additional shipping and handling charges.

DELIVERY TIME

Orders placed before January will begin shipping in January. Delivery dates and times will be arranged between Sow Local Seed and the customer. Free delivery and installation are offered on initial seed rack purchases within HRM. Please contact Erika@sowlocalseeds.ca if your store is located outside of these boundaries and we'll work out an arrangement.

CONDITIONS OF SALE

We ask that retailers not sell our seed after the year for which it is packed. We suggest that the retailer discount any unsold seed packets at the end of

the season and donate unsold seed packets to local organizations. Sow Local Seeds has built a reputation for providing quality seed and reserves the right to refuse a reorder to any distributor who does not comply.

RETURNS

No returns are available through the Outright Sales program option.

If you have chosen the Guaranteed Sales option, we accept return of unsold seed packets at the end of the season, subject to the following conditions:

- (1) Returns require prior approval from Sow Local Seeds before shipping in order to receive credit. When reporting items for return we need the following information: your invoice number or order number, your name and contact information, and the number of packets you are returning.
- (2) Up to 25% of the current season's seed packets ordered may be returned for a 90% credit.
- (3) Packets must be returned in saleable condition to receive the full rebate. Packets must be free of price tags, tape and other damage or alterations. Packets must have been stored/displayed in an appropriate environment (dry, cool and out of direct sunlight).
- (4) Returns must be mailed before October 1st to receive credit.
- (5) Credit will expire April 30th the following year.

CLAIMS

We take care to ship your order in excellent condition, but errors can occur. Please report any defects, shortages, or overages in your order to us immediately so we can remedy the error. Orders that are returned or refused will be charged a 20% restocking fee.

The restocking fee does not apply to returns within the Guaranteed Sales program.

OUR GUARANTEE

We guarantee our seeds to be of high quality and true to name. All seed packets are labeled according to Federal regulations. We do not sell imported or commercially produced seeds. Some varieties may be out of stock because of growing conditions beyond our control. We reserve the right to make appropriate substitutions. Feel free to write specific comments regarding substitutions.

To keep prices low, no fee is charged for the use of the wooden display structures. The wooden display units are the property of Sow Local Seeds. Sow Local Seeds reserves the right to remove the display unit if participation in the program is discontinued for any reason. ROLLOVER OPTION

To keep seed racks fully stocked year-round, Sow Local Seeds begins shipping seed packets labeled for the following year after August 1st. Exact dates are dependent of the germination test dates.
